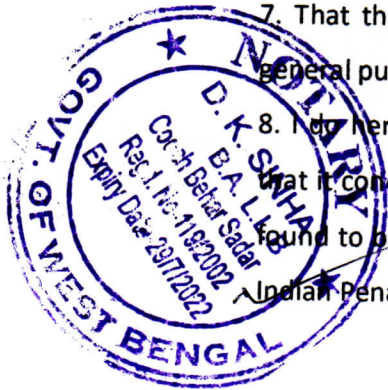
3. That the land is on ownership basis/lease basic for a minimum period of life time years .
